The student is a South African citizen who is a verifiable member of either; the Land Claimants Communities of iSimangaliso Wetland Park or a resident of the UMkhanyakude District Municipality within areas that are close to iSimangaliso Wetland Park or the Mfolozi Local Municipality particularly the Sokhulu area.
